Our upcoming Residential Facility which is focused to give children with special needs, a place to live with dignity and care and not have their parents worry about them, has also progressed satisfactorily.










**Statistics**

We celebrated Independence Day at the Centre. National Flag was hoisted. Cultural performance was given by the children.


### **Online Dance Competition**
