

It was particularly very encouraging to see that despite many challenges, our fundraising team ensured that we were able to continue with our work smoothly.


Our residential facility achieved another milestone. Construction of two Family Homes was completed and another one is under construction which is likely to be completed by July 2023.

I sincerely hope that we will be able to make much more progress in the year 2023-24.




NUMBER OF BENEFICIARIES




NUMBER OF EMPLOYEES
