## **Message from the President**



Dear Friends,

The last quarter beginning was full of activities and achievements.

However, the quarter ended on a very unpleasant note. Coronavirus reached India and it brought the challenges currently faced by the whole world. In the initial days, we took all the necessary preventive measures to ensure all the children and staff remain safe from the spread of the Virus through the availability of sanitizers, discontinuation of the Biometric machine, etc. As soon as the government announced the closure of all schools, we promptly ensured compliance.
