It was good to see the progress in the last quarter. The stability in the classes was visible with the increase in strength of the children post—Covid. The number increased from 65 to 80 and now we are optimistic that the strength will further increase.



Since the children returned to the center after a long time, we noticed their condition had fallen back. We thus decided to reassess all of them and finalize new therapeutic and learning schedules for them. Sports, Yoga, and Music classes have been restarted.

Parents and the caregivers of the children are more relaxed as their child is taken care by Khushboo for 5-6 hours and they can continue with their means of livelihood


Tauru project saw the completion of construction of utilities buildings and one staff quarter cum site office. However many more milestones need to be crossed. The construction of two-family homes has also started.


We look forward for your continued support to our efforts to make our special children more self-reliant.


