Many parameters are fast reaching the pre-Covid levels, the most important being the number of children under our care. We crossed the 95 figure for the first time after Covid. Our physiotherapy section regained its original capacity with the addition of a physiotherapist.

The residential project is also close to reaching a milestone, with 2 family homes nearing completion.

Fundraising continues to be an area of concern. State Bank of India Foundation signed a 3-year MOU, committing Rs.30 Lacs per annum.

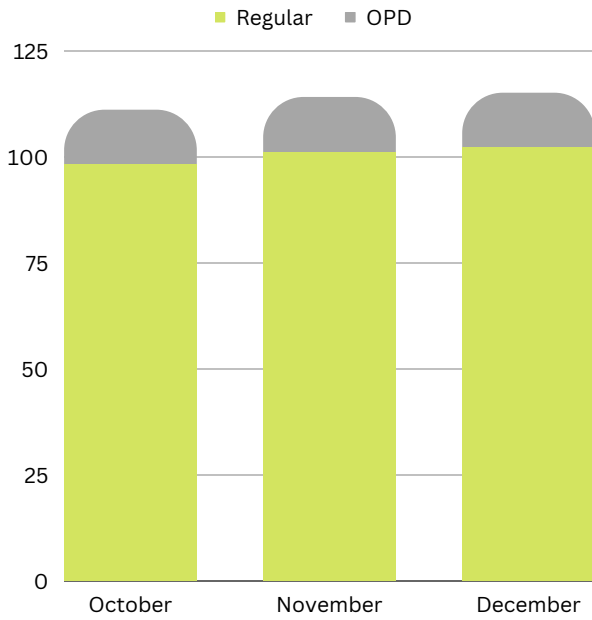
Despite this, the funding gap is still very large. I hope, we will receive sufficient and timely support from donors, which will enable us to continue our work.

Once again, wishing you and your families the very best for the New Year.

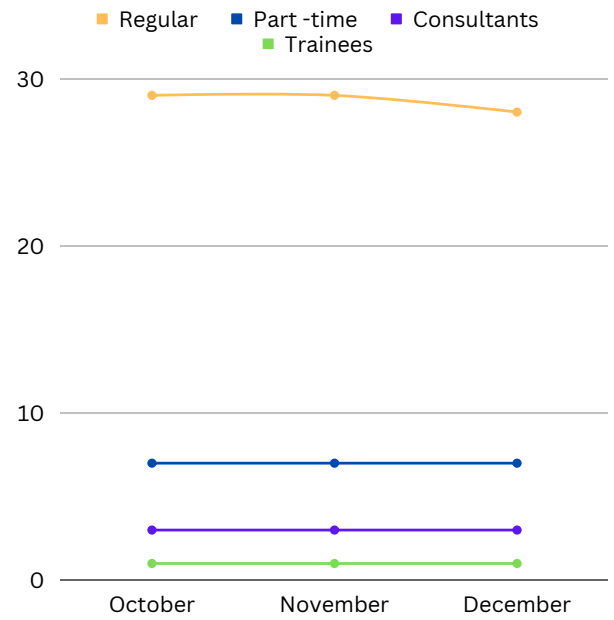

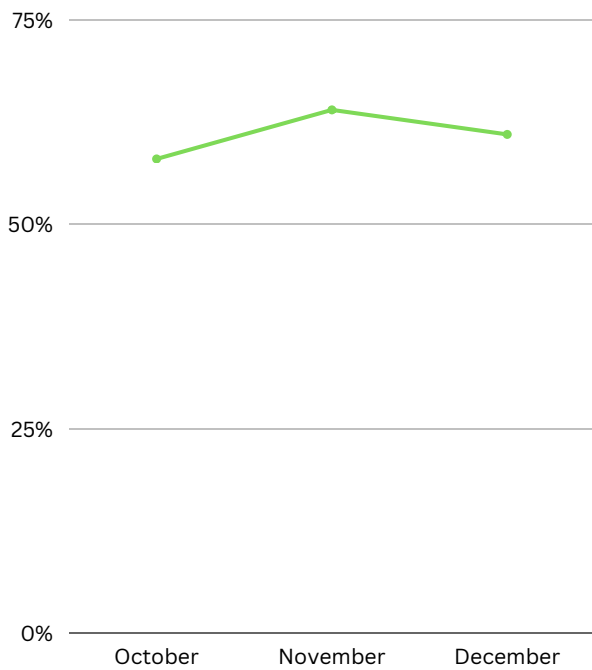
NUMBER OF BENEFICIARIES



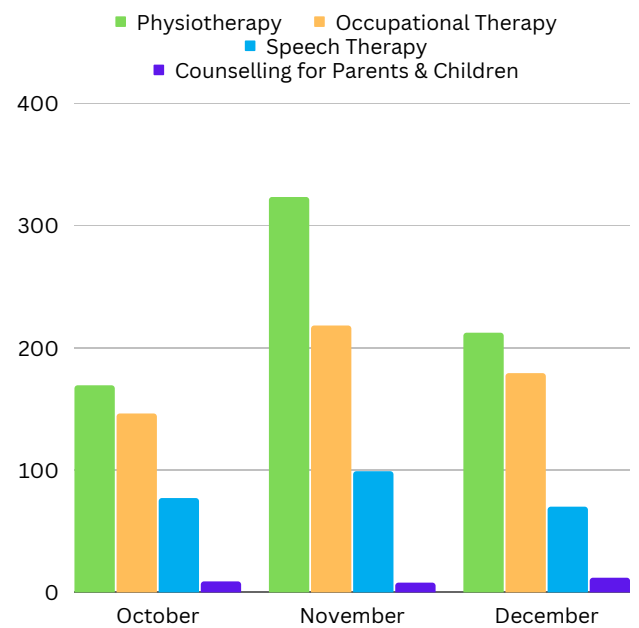
NUMBER OF EMPLOYEES

MEETINGS & MEDICAL CAMPS

26th November 2022: Workshop on Understanding Sensory Dysfunction Management

An open workshop was organized by Mr. Lalit Kumar (Occupational therapist) on Understanding Sensory Dysfunction Management. Sensory issues in children with special needs are a major problem faced by their parents, caretakers and teachers. These issues interfere with daily life whether it's playing, studying, eating or learning. The purpose of organizing the workshop was to address these issues and train parents to overcome such problems.



29th December: Eye Check-up

2 Doctors (Eye specialists) from Ahuja Eye & Dental Institute, Gurgaon visited our Centre to examine children. They examined 50 children and staff and gave proper advice. They referred 10 children to Clinic for a detailed examination and promised to provide 11 children's glasses free of cost.
