The newsletter gives details about these and other activities of the Center.


I hope the contents will motivate you to join us in this transformative journey of our special children, support our cause and strengthen our hands to make them more self-reliant.




NUMBER OF BENEFICIARIES






AVERAGE ATTENDANCE
