A quarterly update from the President of Khushboo

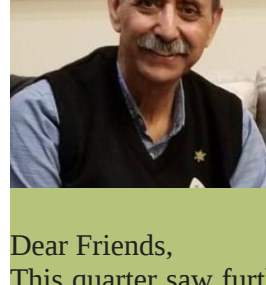

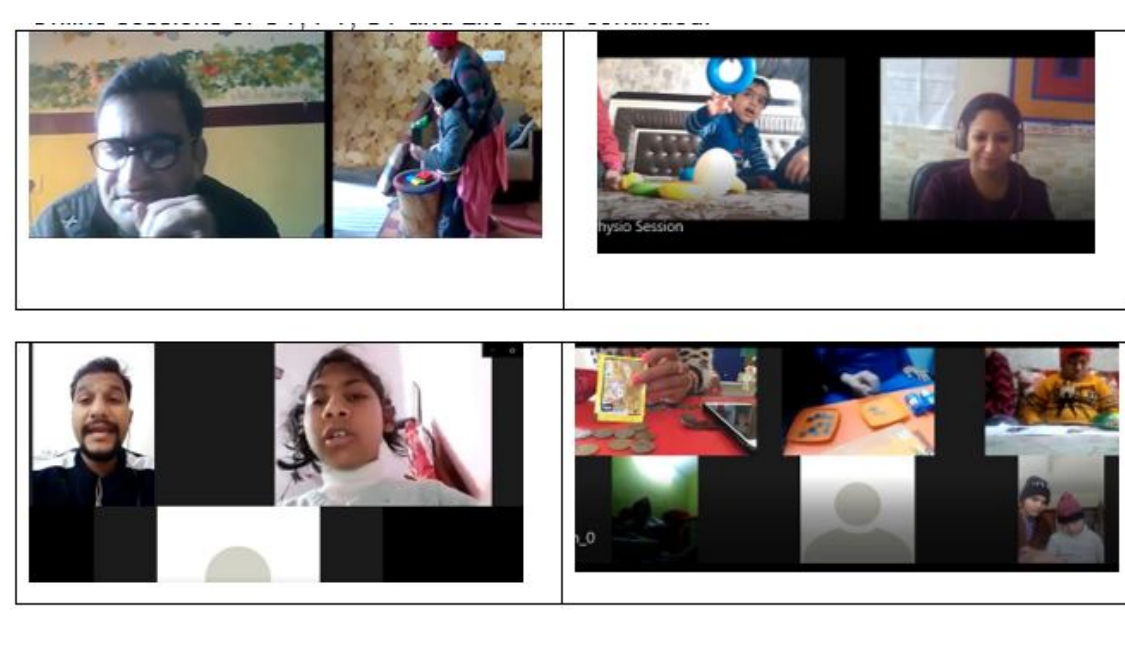

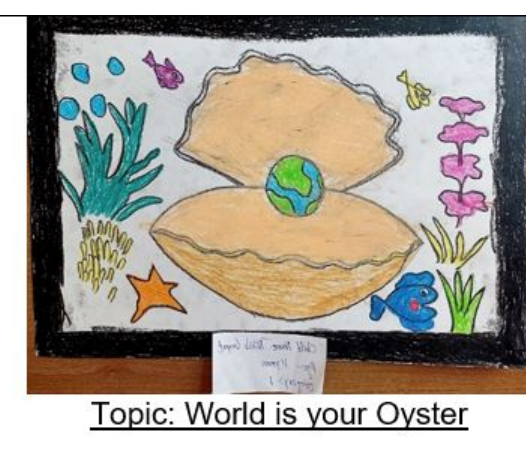
Center Visit by City Magistrate Gurgaon
