Message from President



Dear Friend,

COVID pandemic has disrupted the whole world.

Social sector has not escaped its wrath, effect being similar, if not more.

The impact has been on two fronts, one the inflow of funds and two the ability to deliver services.

Reduction in organizations' surpluses coupled with pressures to support COVID programs have forced them to reduce, if not stop support to their existing CSR partners. Khushboo too is facing a similar situation and is trying to locate new partners to substitute the drop in funds inflow.

With the physical classes not being permitted, Khushboo staff has been trying to find alternate ways to provide support and services to the children under our care. For these children, discontinuation of therapeutic activities has serious implications on their physical condition.

I complement our staff for while learning online teaching, almost simultaneously creating & delivering these programs to the children.

With restrictions now being relaxed, we hope to be able to start, at least individual therapeutic sessions.
