

Silver Jubilee Celebration




A Medical consultation was held on Zoom. 6 children with their parents were attended by Pediatric Orthopedic Surgeon Dr. Sanjay Sarup.

Project Update: Land for the project has been purchased, the detailed architectural panning has been completed, approval of building plans has been obtained, electricity and water facility has been made operational, boundary wall has been completed and the construction of the first phase of the project ie site development, security office, site office and caretaker residence has been started, and expected to be completed by end March 2021.
