Khushboo was able to restart physical classes and progressively the number of children coming to the Center reached 49.

The Annual General Meeting which was held on 17th Oct to review Operational Activities and Annual Accounts for the year 2020 - 21. Elections were also held to form a new Executive Committee. Mrs. Seema Krishnan was added to the outgoing Executive Committee.

Our upcoming Residential Facility which is focused to give children with special needs, a place to live with dignity and care and not have their parents worry about them, organized a disability identification and awareness camp at the residential project site, Tauru. The prime purpose of the camp was to establish a relationship with the local people. 18 children and adults with different disabilities, were attended to by our staff.

During this quarter, we have also helped 2 eligible applicants to get the Legal Guardianship Certificate, being the NGO member of the Local Level Committee (National Trust) for the Gurgaon District.

Also happy to share that we celebrated world disability day on Dec 3 with SGT University students. Our children enjoyed this day as the university students performed plays on the stage and finally, our children too danced with them.

We won the 3rd prize under "Project Discovery (Video Solutions)" conducted by EI – Labs EnAble India. This was a video competition organised for NGOs working on disability. aimed at showcasing innovative solutions for care of persons with disabilities. The prize also carried an award of Rs.25000/-

We had the EC meeting to review operations for July – September quarter.


It is heartening to share that four of our children participated in State Championship for Power Lifting organized by Special Olympics Bharat at Tau Devi Lal Stadium.



No. of children in OPD




Occupational Therapy



Annual General Meeting




