A group from Inner Wheel Club visited our centre and donated Rs.1 lakh for musical instruments, mattresses, UPS and furniture for children.

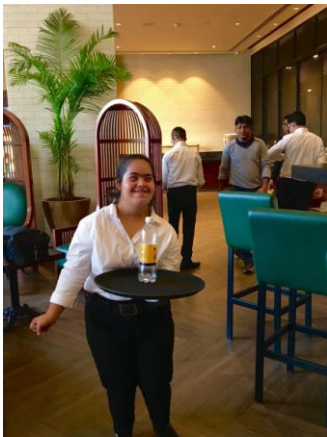
Meetings and Trainings
